Meeting called to order at 6:08 p.m. by Supervisor Brooks. Held on Tuesday, December 10^{th,} 2024 at the Denning Town Hall.

Present: Supervisor Brooks Councilmen: Gregory Vurckio, Kevin Smith, Mike Dean, and Scott Mickelson. Highway Superintendent Leonard Johnson. No Public Present

The Town Clerk Minute Book was signed prior to the meeting commencement.

The Town Clerk gave the Board members their copy of the Agenda and Resolution No. 59 of 2024, the Adopted 2025 Town of Denning Budget, the November/December Talk of the Towns magazine from the Association of Towns, and the Budget vs. Actual through November 2024.

Supervisor Brooks inquires if all of the Councilmen have read the Minutes and asks if there are any amendments. All respond that the Minutes have been read and that there are no amendments.

Correspondence – by Supervisor David Brooks.

- Supervisor Brooks is in receipt of the CWC Board of Directors Nomination form. Discussion follows with the Town Board regarding nomination of James Sofranko. The Board is in agreement.
- Email received from Officer Howard Kreft with information regarding partial list of government agencies and fire departments who were involved during the Whitehouse Fire in Sundown/Peekamoose. A full list is still being compiled for an official Town Resolution. Supervisor Brooks states that if anyone is looking to make a donation to the Grahamsville Fire Dept. they have recognized the need to purchase a UTV to aide in fighting wildland fires.
- Received donation check on 11/19/24 to the Town from the Frost Valley YMCA in the amount of \$11,415.00 for the month of October. Supervisor Brooks and the Denning Town Board express their gratitude to CEO Riel Pierbooms and the Frost Valley Board of Trustees for their ongoing support.
- Supervisor Brooks reviewed documentation from other Ulster County towns regarding dog licensing fees when researching the Denning fees. He suggests raising the Denning fees from \$5.00 per year for neutered dogs to \$6.00 per year; and raising the fees from \$12.50 per year for non-neutered dogs to \$15.00 per year. Discussion follows. All Board members agree to the new fees for 2025.
- > Check received from Weitsman Shredding LLC in the amount of \$566.89.
- Check received from Ulster County in the amount of \$15,909.21 for Denning sales tax collected September to November 2024.
- Letter and documentation received from Catskill Hudson Bank regarding merger with Hudson Valley Credit Union expected to be completed on or about January 31, 2025. The system and account conversion will occur post-merger and is presently targeted for the first quarter of 2025.
- Email received from NYS Department of Financial Services regarding the Banking Development District designation determination timeline. The determination

timeline has been extended to February 14, 2025 to coincide with the bank and credit union merger timeline.

- Letter received from part-time resident on Porcupine Road, Albert Pinand, regarding the many Short-Term Rentals in Denning, issues caused by the STRs, and the current Zoning Law. Discussion follows.
- Letter received from Ulster County Transportation Council regarding the Transportation Improvement Program (TIP) update process. The letter also states that the replacement of the Denning Road bridge over East Branch of the Neversink River is slated for 2027.
- Supervisor Brooks informs the Board that the Town Hall boiler had recent issues. Bottini came and serviced the boiler and it is running well now. Customer satisfaction survey was received from Bottini and completed by the Town Clerk with information regarding billing timeliness and allocation of payment issues that will hopefully be addressed by Bottini in the future.

Highway Report: by Highway Superintendent Leonard Johnson.

- > Winter Storm work, plowing and sanding of roads.
- > Cutting downed trees out of roads and ditches.
- > In shop work cleaning and repairing trucks and plows, changing oil.
- Hauled sand and mixed salt and sand.
- > Ready for future weather events.
- > Freightliner is down again. Front end issues. It is at Prestige.
- New truck is running well. No lights on and no noises or issues.
- > Garage doors are falling apart due to age and condition. Recent repairs made.
- Emergency radios are not working well. Technician says we need a repeater. Discussion follows.
- Pestmaster of Kingston. Firm hired to deal with racoon and rodent issues at Town Barn and Town Hall. Seems to be going well. Will keep the Board updated.

Planning Board Report - by Liaison Councilman Kevin Smith.

- Planning Board meeting in November had Public Hearing for STR for McGarity at 24 Woodfield Road. Public was present and heard for and against. Planning Board will vote on this matter at December meeting.
- Planning Board members are working on amendments to be made for zoning for STRs. Preparing paperwork for submission to Town Board for consideration.

Supervisor Comments:

- The CWC representative is coming to Denning on Monday, December 16th to finalize application for the project to armor the Sundown Road.
- Supervisor Brooks reports that investigation of the start of the Whitehouse Fire in Sundown is ongoing and that he is keeping tabs on it.
- The NYS State of Emergency ended on November 30th and the Denning State of Emergency ended today. Supervisor Brooks reports that there is no need to renew it at this time with the snow we received and the upcoming wet weather. Supervisor Brooks suggests updating the Town of Denning Burning Permit information. Discussion follows.
- It is brought to the Board's attention that there is a need for a vehicle for the Dog Control Officer. Discussion follows. Councilman Scott Mickelson will look into finding an SUV for this purpose with an approximate \$10,000.00 to \$15,000.00 budget. It is suggested that he check online auctions and used government vehicle websites for research. The new Dog Control Officer, Jane Witthohn, will be meeting with the NYS Agriculture and Markets representative regarding the DCO position on Tuesday, December 17th.
- Highway Superintendent Johnson has a meeting with the State regarding tree cutting on Tuesday, December 17th. Discussion follows.

Supervisor Brooks calls for Councilmen Comments:

- Councilman Vurckio informs the Board regarding the November 18, 2024 CTW meeting:
 - LAP/SAP Negotiations
 - No major changes still heading in a positive direction. Small groups were set up to address remaining issues.
 - Conservation Easements to the State
 - This matter is close to a full agreement.
 - CWT was supportive of solar projects by the City with a 2 acre / 5 acre maximum. Solar farms are good in the right locations but not in farm land or usable property. NYC DEP is required to meet local Town/Village laws before

moving forward with any projects. CWT stressed it is important to have a solar farm law set up in Towns, etc. It is confirmed that solar farms are addressed in the Town of Denning Zoning Law.

- No news on the wetland regulations at this meeting.
- Councilman Scott Mickelson informs the Board that the eviction matter is ongoing before the Court and Judge Follender hopes to have a jury trial on the matter. Discussion follows. The Barnes Road resident open burning issue has been continued to the next Court date. There is a matter which is being transferred from the Town of Wawarsing Justice Court due to a conflict of interest. The next Court date is December 18th.
- Councilman Mike Dean requests information regarding who is responsible for plowing the Red Hill Fire Tower parking area at the trailhead. Supervisor Brooks notes that it is the State. Councilman Dean noted that it was not plowed over the weekend and there were a number of cars parked on the road. It has since been plowed. Supervisor Brooks will call the State. Discussion follows regarding the bridge near that location that needs repair. Highway Superintendent Johnson reports that Ulster County recently inspected it. Construction is slated for 2027. Superintendent Johnson states that the steel is still good but decking is disintegrating.
- Councilman Smith reports that the Planning Board has been working on amendments to the Zoning Law regarding Short Term Rentals. Supervisor Brooks asks that the Planning Board come up with a final maximum number of STRs for the Town. Trying to determine a percentage would be too difficult and will not work. Trash and dogs are what we are getting complaints on at Town Hall regarding STRs. Supervisor Brooks reports that Karl Von Hassel will be contacting the residents who are on the current Ulster County list for STRs to come into compliance with yearly inspections, etc.

Supervisor Brooks calls for any further councilmen comments or discussion. There is none.

No Public present for comments.

Motion to Enter Executive Session at 7:00 pm to discuss Personnel matters is made by Councilman Gregory Vurckio and Seconded by Councilman Scott Mickelson. All in Favor.

No decisions were reached during Executive Session.

Motion to adjourn Executive Session and the Town Board meeting at 7:14 pm made by Councilman Gregory Vurckio and seconded by Councilman Scott Mickelson. All in Favor. Motion Carried. Meeting Adjourned.
